

## Master of Dental Surgery Residency Training Programme Admission Fact Sheet

### About the Programme

This is a 3-year full-time structured didactic and clinical training programme and is offered in 6 specialties. The course commences in July.

### Entry Requirements

For admission as a candidate to the course leading to the degree of Master of Dental Surgery, candidate must –

- Hold a basic dental degree qualification (Bachelor of Dental Surgery or equivalent);
- Have at least two years full-time clinical experience in general dentistry after graduation (excluding internship);
- Complete the TOEFL or IELTS if the native tongue or medium of undergraduate instruction is not English. The minimum acceptable scores are: TOEFL score – 580 (paper-based), 237 (computer-based), 92 (internet-based) & above or IELTS – 7\*.  
\*Only National University of Singapore (NUS) graduates & native English speakers from G7 (France, USA, UK, Russia, Germany, Italy and Canada) countries are exempted.
- Application for **Oral & Maxillofacial Surgery and Orthodontics**: Have a pass in the Part I MDS Examination or equivalent. Candidates without a pass in the Part I MDS Examination may apply for admission and be considered for candidature on the condition of passing the Part I MDS Examination or equivalent prior to the commencement of the interview.

### Health Requirements

In accordance with the Ministry of Health requirements, admission to Dentistry is subject to the following virus screening and immunization:-

- 1 Hepatitis B Virus (HBV) – All prospective students must be tested HBsAg negative. Those who are tested negative but are not immune are required to be immunized so as to prevent HBV transmission in healthcare workplace. All immunizations must begin within one month from the date of screening.
- 2 Varicella Zoster Virus (Chickenpox) - All prospective students must undergo screening for immunity to the Varicella Zoster Virus (VZV). Those tested negative for VZV immunity will be required to be immunized within one month from the date of screening.
- 3 Rubella Virus - All prospective students must undergo screening for immunity to the Rubella Virus. Those tested negative for Rubella immunity will be required to be immunized within one month from the date of screening.

Attendance in person is compulsory for acceptance into the course. Candidates for selected specialties may also be required to take pre-admission written and/or manual dexterity tests.</p>

<b>Basic Medical Sciences/ Part 1 MDS Examination – Open to Public</b>	
<b>Basic Medical Sciences Course</b>	<p>The Basic Medical Sciences (BMS) course is an intensive 2-week preparatory course that prepares candidates for the Part 1 MDS Examination. The BMS course is conducted in September.</p> <p>Registration Fee is <b>S\$1,200</b> (inclusive 7% GST)</p>
<b>Part I MDS Examination</b>	<p>The Part I MDS Examination is conducted in November. The examination is conducted over a period of 2 days and consists of:</p> <ol style="list-style-type: none"> <li>1. one essay paper;</li> <li>2. one multiple-choice question paper; and</li> <li>3. oral examinations on <ul style="list-style-type: none"> <li>- Anatomy and Dental Anatomy</li> <li>- Pathology including Microbiology</li> <li>- Physiology</li> </ul> </li> </ol> <p>Registration Fee is <b>S\$300.00</b> (including 7% GST) – Non-refundable</p>
