Management of Deep Caries – Vital Pulp Therapy or Root Canal Treatment (Classroom and Practical Training)

Target Audience: General Dentists

Traditionally, clinicians are familiar with full pulpectomy and root canal treatment as the first-line option for managing pulp which is deemed irreversibly inflamed. In recent years, vital pulp therapy in mature teeth has been reexamined with renewed interest and is gaining traction. It is, therefore, meaningful to review and consider this potentially conservative approach as part of our daily practice.

Through this intensive hands-on workshop, participants will:

- 1. Appreciate the clinical and histological presentation of caries and endodontic diseases:
- 2. Understand the challenges of diagnosing pulpal conditions, the available treatment modalities and the factors affecting the case selections;
- 3. Apply the use of bioceramic materials in vital pulp therapy; and
- 4. Be exposed to various rotary instruments and learn how to use them safely and efficiently.

Requirement

Participants are required to bring 5 extracted teeth (preferably carious).
