Restorative Workshop Series 1 Management of Deep Caries – Vital Pulp Therapy or Root Canal Treatment?

Traditionally, clinicians are familiar with full pulpectomy and root canal treatment as the first-line option for managing the pulp deemed to be irreversibly inflamed. In recent years, vital pulp therapy in mature teeth is being re-examined with renewed interest and is gaining traction. It is perhaps time to re-examine and incorporate this potentially conservative approach, as part of our daily practice.

Through this intensive hands-on workshop, participants will:

1. appreciate the clinical and histological presentation of caries and endodontic diseases;
2. understand the challenges of diagnosing pulpal condition, the available treatment modalities and the factors affecting the case selections;
3. apply the use of bioceramic material in vital pulp therapy, and
4. be exposed to various rotary instruments available in the market and familiarise with their usage in safe and efficient manner.
