Restorative Workshop Series 1 Management of Deep Caries – Vital Pulp Therapy or Root Canal Treatment?

Traditionally, clinicians are familiar with full pulpectomy and root canal treatment as the first-line option for managing pulp which is deemed irreversibly inflamed. In recent years, vital pulp therapy in mature teeth has been re-examined with renewed interest and is gaining traction. It is, therefore, meaningful to review and consider this potentially conservative approach as part of our daily practice.

Through this intensive hands-on workshop, participants will:

1. Appreciate the clinical and histological presentation of caries and endodontic diseases;
2. Understand the challenges of diagnosing pulpal conditions, the available treatment modalities and the factors affecting the case selections;
3. Apply the use of bioceramic materials in vital pulp therapy; and
4. Be exposed to various rotary instruments and learn how to use them safely and efficiently.

Participants are required to bring 5 extracted teeth (preferably carious).
