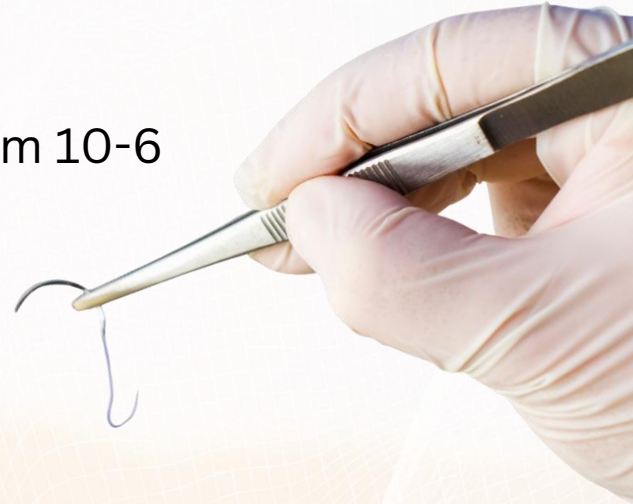

Prof. Alvin Yeo is currently working as an Associate Professor and Senior Consultant at the National University of Singapore (NUS) and National University Centre of Oral Health Singapore (NUCOHS) respectively. He assumes the position of Director of the Postgraduate Residency Program in the Department of Periodontics at the National University of Singapore. In addition, he is currently a member of the Dental Specialist Accreditation Council (DSAC) in Periodontics assigned to conduct exit assessments and recommendations for new Periodontist specialist accreditation.

He graduated in Periodontics at the University of North Carolina at Chapel Hill, USA in 2003 with a Certificate in Periodontics and a Masters of Science (MS) degree in Oral Biology. He received his Bachelor of Dental Surgery (BDS) degree from the NUS in 1997. He was conferred Fellow in the Academy of Medicine, Singapore (FAMS) in 2007. He was awarded a Doctorate of Philosophy (PhD) from the University of Groningen, Netherlands after successfully defending his PhD thesis in March 2010 entitled “Novel Polycaprolactone-Tricalcium Phosphate (PCL-TCP) Scaffolds Customized for Reconstruction of Dentoalveolar Deformities.”



Prof. Yeo's major clinical and research interests include the evaluation of novel biomaterials and scaffolds for dentoalveolar ridge augmentation and dental implant related therapy. In addition, he has extensive clinical experience in the management of periodontal disease both surgically and non-surgically. Prof. Yeo held several positions in organizations and committees locally and internationally. Prof. Yeo had been extremely active and is part of the Founding member and the Leadership Team of the ITI South East Asia (SEA) Section formed in 2011. He assumed the role of ITI SEA Section Education Delegate from 2011-2015 and was past-Chairperson the ITI SEA Section from 2016-2019. Prof Yeo sits on the Editorial Advisory Board of the “Journal of Periodontology” and is also a member of Editorial Board of the “ITI Forum Implantologicum” publication.

# **NUS Dentistry Course Registration, Payment, Withdrawal, and Cancellation Guidelines**

## **1. Registration**

- **Application Processing:** All applications are processed strictly on a *first-come, first-served* basis.
- **Notification Period:** Applicants will receive an email containing course details and payment instructions within one (1) week of submitting their application.
- **Confirmation of Enrolment:** Enrolment is deemed confirmed only upon full receipt of the course fee by NUS Dentistry.

## **2. Payment**

- **Mode of Payment:** Course fees are payable via PayNow.
- **GST Inclusion:** All published course fees are **inclusive of the prevailing Goods and Services Tax (GST)**.

## **3. Withdrawals and Refunds**

### **3.1 Withdrawal Procedure**
