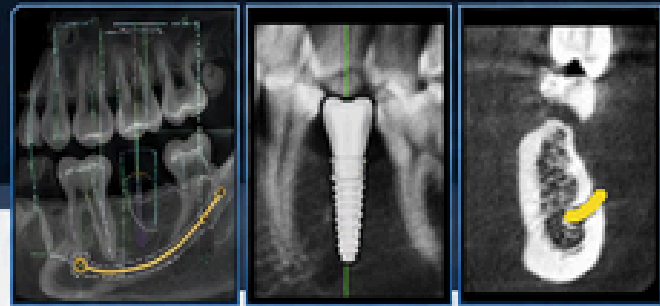

Dr Lim Li Zhen is Senior Lecturer at the Faculty of Dentistry, National University of Singapore (NUS), and a Consultant at the National University Centre for Oral Health, Singapore (NUCOHS). She received her Bachelor of Dental Surgery degree from NUS in 2010, where she was the recipient of multiple academic awards. In 2014, she received the NUS-Overseas Graduate Scholarship to pursue a Master of Science degree in Oral and Maxillofacial Radiology (OMR) at the University of North Carolina at Chapel Hill. Upon graduating in 2017, she was the first Singaporean to complete a full-time 3-year residency programme in OMR. She received her board certification from the American Board of Oral and Maxillofacial Radiology in 2018.

She teaches modules in oral radiography and radiology to undergraduate and postgraduate dental students. Her research interests include evaluating the diagnostic impact and efficacy of imaging, and the use of technology-enhanced learning in dental education.

A/Prof Alvin Yeo is currently working as an Associate Professor and Senior Consultant at the National University of Singapore (NUS) and the National University Centre of Oral Health Singapore (NUCOHS), respectively. He assumes the position of Director of the Postgraduate Residency Programme in the Department of Periodontics at the National University of Singapore. In addition, he was recently appointed as the Assistant Dean for the Centre for Advanced Dental Education (CADE) at NUS Faculty of Dentistry.

A/Prof Yeo graduated in Periodontics at the University of North Carolina at Chapel Hill, USA in 2003 with a Certificate in Periodontics and a Masters of Science (MSc) degree in Oral Biology. He received his Bachelor of Dental Surgery (BDS) degree from the NUS in 1997. He was conferred Fellow in the Academy of Medicine, Singapore (FAMS) in 2007. He was awarded a Doctorate of Philosophy (PhD) from the University of Groningen, Netherlands after successfully defending his PhD thesis in March 2010.

A/Prof Yeo holds several positions in organisations and committees locally and internationally. He was recently appointed as a member of the Dental Specialist Accreditation Board (DSAB) from April 2026, after completing a 12-year tenure (2014–2026) on the Dental Specialist Accreditation Council (DSAC) in Periodontics, contributing to exit assessments for specialist accreditation.

He has been extremely active and is part of the Founding member and the Leadership Team of the ITI South-East Asia (SEA) Section formed in 2011. He assumed the role of ITI SEA Section Education Delegate from 2011-2015 and was the past-Chairperson of the ITI SEA Section from 2016-2019. He sits on the Editorial Advisory Board of the “Journal of Periodontology” and is also a member of the Editorial Board of the “ITI Forum Implantologicum” Journal.

# **NUS Dentistry Course Registration, Payment, Withdrawal, and Cancellation Guidelines**

## **1. Registration**

- **Application Processing:** All applications are processed strictly on a first-come, first-served basis.
- **Confirmation of Enrolment:** Enrolment is deemed confirmed only upon full receipt of the course fee by NUS Dentistry.

## **2. Payment**

- **GST Inclusion:** All published course fees are inclusive of the prevailing Goods and Services Tax (GST).

## **3. Withdrawals and Refunds**

### **3.1 Withdrawal Procedure**

- Participants must submit their withdrawal request in writing via email.
